Outcome: Auditors start the audit already 50–70% complete, improving accuracy and consistency.

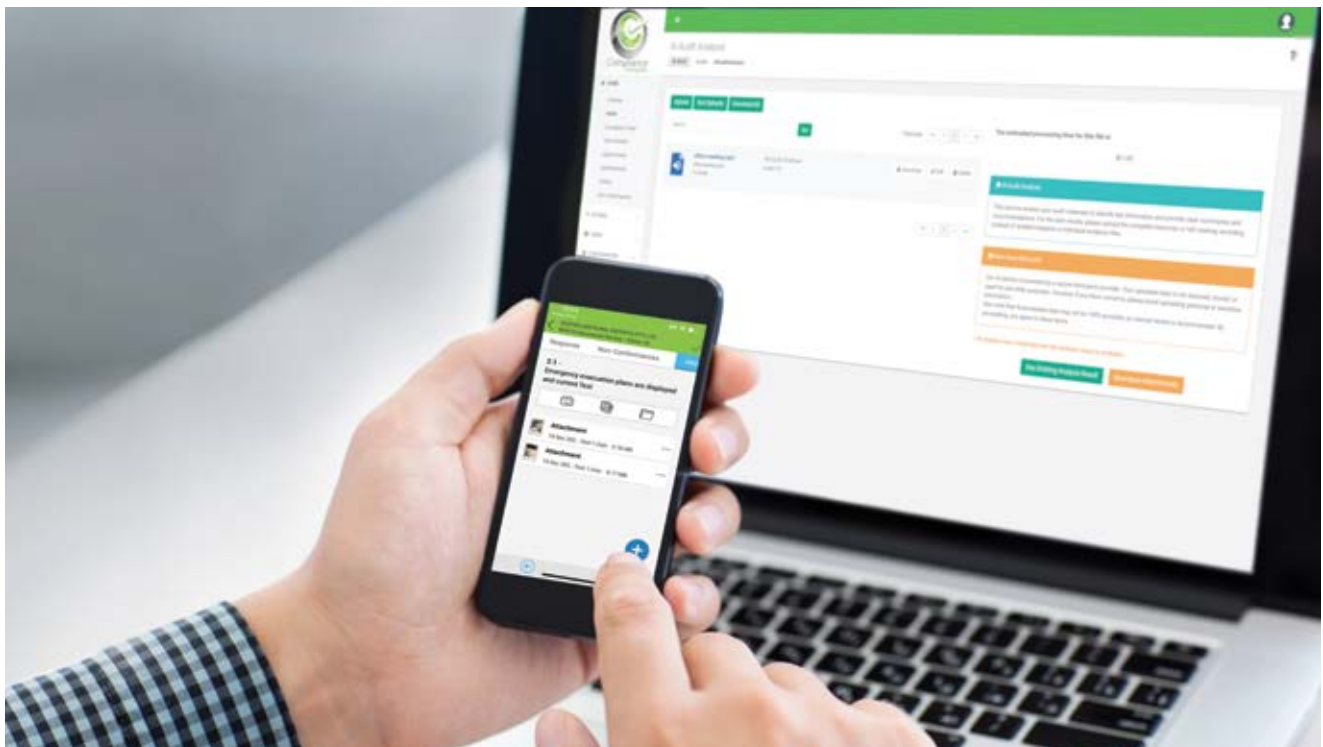

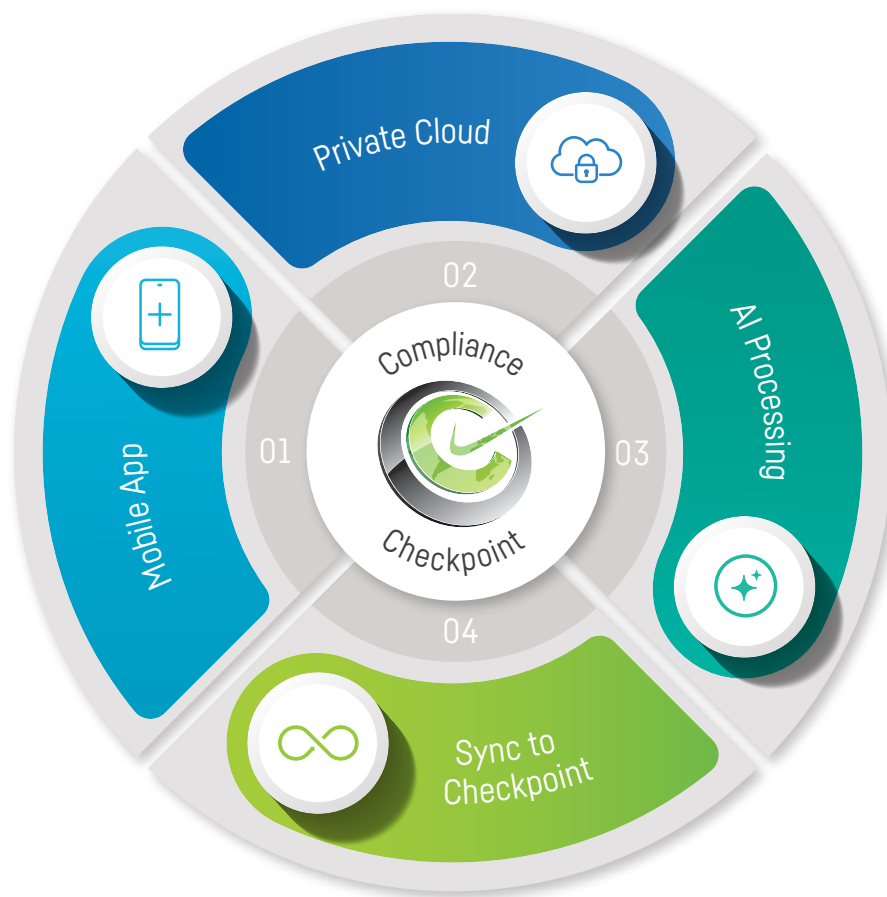

Capture via Mobile App:

- IOS / Android.
- Only data capture is done locally (eg. photos, docs, voice).
- No AI models or data extraction run on the device—key for security and privacy.

Sync to Private Cloud

- Captured data uploads securely to private cloud storage.
- Avoids filling local mobile storage/data allowance.
- Reduces risk from BYOD or lost devices.

AI Processing in Cloud

- Heavy AI tasks—document parsing, transcription, summarisation—run securely in the cloud.

Sync back to Checkpoint

- Results sync back into the Checkpoint dashboard for review and action.

This architecture ensures sensitive compliance data is never stored on personal devices, saving mobile resources and strengthening security. It combines mobility, privacy, and performance in a modern compliance workflow.
